## HOW DOES OUR LOS ANGELES GOVERNMENT WORK?

At the top of any government organizational chart is the "Electorate." That's you and me, the voting public. We vote into office our officials in the three branches of our local government: The Mayor, he City Council (with 15 districts in the City of Los Angeles) and the County Board of Supervisors (with 5 districts in Los Angeles County).

The Mayor is **elected by all the voters** in the City of L.A. The City Council Members and the County Board of Supervisors are **elected by the voters in their districts.** All elected officials are responsible to the citizens of the city and county, and are paid by public funds.

# WHAT ARE NEIGHBORHOOD COUNCILS? HOW DO THEY WORK?

Several years ago, in an effort to discourage secession, the City Charter created Neighborhood Councils, to be monitored by a new city agency, DONE (Dept of Neighborhood Empowerment). These NCs were self-organizing: Individuals in an area got together and decided where the boundaries for each NC should be. There are 95 NCs in the city, 86 of which have been certified by the city. Our NC, which is certified, is the Hollywood Hills West Neighborhood Council (HHWNC). All NCs hold regular meetings and each year every NC receives \$50,000 in public money and is accountable to the city which regulates the use of these funds.

Individuals who sit on the Boards of these NCs are elected by the stakeholders in the NC area. A "stakeholder" is anyone who lives, works or owns property in a NC area, or who participates in groups such as schools, religious organizations, community and homeowner associations, chambers of commerce, etc. All you have to do to become a registered stakeholder (so you can vote for these Board members) is to attend a NC meeting and sign up. There are **no dues to pay**; **membership is free.** The CPPOA fully supports the NC process.

These Neighborhood Councils are <u>advisory only</u>. The Charter created the NCs to have an advisory role on issues of concern to the City's neighborhoods. All NC Board members are serving on a <u>volunteer</u> basis. No one is paid. They are not employees of the city nor do they have the right to represent the city in any way or to speak for the city.

In very large NCs, like our HHWNC, there are Area divisions with Area Chairs. Our Cahuenga Pass neighborhood is in **Area 2**. As with the NC Board, all Area Chairs are <u>volunteers</u>. They are not city employees, they are not paid by the city, they do not have any <u>decision-making power</u> and they do not represent the city or the <u>city's position in any way</u>. Their role is to help the city disseminate information to the neighborhood.

## **DEVELOPMENT UPDATE**

**BRAILLE SITE** (3520 Cahuenga Blvd West) 65 live-work condos are coming on this site, along with two planted medians on Cahuenga Blvd West in front of the property. Target completion date: Summer 2008.

HANNA-BARBERA (3400 Cahuenga Blvd West) This project is entering its final stage. L.A. Fitness in the northern building is open,

and landscaping and the planted median on Cahuenga Blvd West are almost completed. The middle building will remain as offices with ground-floor retail and offices above in the south building. The new building at the rear of the site has 47 apartments. Developer Bill McGregor has agreed to CPPOA's request to locate a memorial to the Hanna-Barbera animation studio on the property. Target completiondate: Soon!

HOLLYWOOD BUNGALOWS (2775 Cahuenga Blvd West) Planned are 76 loft condos, aimed to sell for \$650,000 to \$750,000. Right now the project is stalled at the Mulholland Design Review Board stage, by the developer's request. Included in the project are (5) 200' planted medians along Cahuenga Blvd West, a new traffic signal and a \$25,000 donation to Cahuenga Beautiful. Completion date unknown at this time.

WHAT'S GOING ON AT UNIVERSAL?

By now we've all read the newspapers and seen the nightly news. We know the MTA and GE/NBC/Universal are planning two of the biggest developments in the history of Los Angeles. One is at the MTA site on Lankershim. The other is on Universal Studios' lot. These two projects are running more or less concurrently. All of the neighborhoods around these two gigantic projects will be forever changed. The question is: What will those changes be?

While we cannot answer that big question yet because the two Draft Environmental Impact Reports (one for each project) have not yet been released, we can tell you about an important group that is closely involved in these two projects on a day-to-day basis.

In the fall of 2006 I was contacted by the Toluca Lake Chamber of Commerce about putting together a citizens advisory group of organizations & NCs that are neighbors of Universal Studios and the MTA site. At the same time our Councilmember Tom LaBonge called me with the same idea. Together we formed an extensive Working Group, now the recognized entity that interfaces with Thomas Properties Group (TPG), the developer of the MTA site and the residential portion of Universal Studios' Vision Plan, and GE/NBC/Universal Studios.

Included in this entity are representatives from our own Cahuenga Pass Property Owners Assn. (Florence Blecher and I are the only two Pass reps), Studio City Residents Assn, Outpost Estates Homeowners Assn, Toluca Lake Homeowners Assn & Chamber of Commerce, Lakeside Golf Club, Hollywood Knolls Community Club, Hollywood Dell Civic Assn, Campo de Cahuenga Historical Memorial Assn, Cahuenga Pass Business Owners Assn, our own Hollywood Hills West Neighborhood Council, Studio City Neighborhood Council, Greater Toluca Lake Neighborhood Coundl & Hollywood United Neighborhood Council. Also present at these monthly meetings are City & County officials, reps from NBC/Universal and TPG.

This group has a lot of folks who are extremely knowledgeable (some are professionals in their fields), experienced in working with these types of developments, and committed to protecting our neighborhoods while still encouraging economic growth. Our motto is:

"Neighbors working together for smart growth."

What I want you all to know is that your association is working diligently on your behalf. No one is asleep at the switch. We're active, we're involved, we're not getting much sleep! But no changes are going to happen in our community without our knowledge and your input. We have the support of our Councilmember Tom LaBonge and our County Supervisor Zev Yaroslavsky. Soon we will notify you of a major Town Hall meeting for all neighborhoods affected by these developments. You will have a chance to find out what changes are in the offing for all of us and how to effectively respond to make sure those changes are Smart Growth.

The Campo de Cahuenga on Lankershim (where the Metro station development will be) is where the Treaty of Cahuenga was signed in 1847. This treaty settled the dispute between Mexico and the U.S. over California. Ownership of the original adobe is unclear but by the 1850's it was a stop for the Butterfield Stage, and later an encampment for the California Battalion during the Civil War. The site is now managed by L.A. Dept of Recreation & Parks as a park and cultural center.
